



Talaat Moustafa Group Holding Best bid for a concession right to develop Four Seasons Hotel in Luxor

Cairo, April 14th 2008 – in continuation of its strategy to expand its hotels and tourism investments, Talaat Moustafa Group Holding ("TMG Holding") announces that the Arab Company for Hotels & Tourism Investment (ICON), a subsidiary of TMG Holding, has offered the best bid for a renewable 50-year concession right of a 20,000 square meter piece of land in Luxor governorate (called Al Sultana Malak) to develop a Four Seasons Hotel on it. Under the concession right, ICON will pay an annual fee starting on January 1, 2012 equivalent to LE 6.84 mn and subject to a 5% annual increase to reach LE 20 mn by 2034 and until the end of the first concession duration by 2062.

Mr. Hisham Talaat Mostafa, Chairman & CEO, announced that winning the concession right for this piece of land is in line with the company's strategy to increase TMG Holding's profitability through increasing hotels' revenue contribution in addition to revenues generated from the Four Seasons Nile Plaza in Garden City, Four Seasons Resort Sharm El-Sheikh, and Four Seasons Alexandria at San Stefano.
